



New Entrant Checklist

Pre-Application Steps

- 1. **Develop a Business Plan**: Outline your business strategy, including the types of goods you plan to transport, your target market, and how you plan to operate your fleet.
- 2. **Choose a Business Structure**: Decide whether you'll operate as a sole proprietorship, partnership, LLC, or corporation. Consult with a business attorney or accountant to determine the best structure for your business.
- 3. **Obtain an Employer Identification Number (EIN)**: Apply for an EIN from the IRS. It's required for businesses operating as corporations, partnerships, or any entity that will have employees.

FMCSA DOT Authority Application

- 4. **Determine Your Authority Type:** Determine the type of FMCSA authority you need based on the freight you plan to haul (e.g., general freight, household goods, hazardous materials).
- 5. **Register for a USDOT Number**: The USDOT Number is a unique identifier for your company and is required for all interstate carriers.
- 6. **Apply for Operating Authority (MC Number)**: Complete the FMCSA's Form OP-1 to apply for your Motor Carrier (MC) Number, which grants you the authority to operate.
- 7. **Designate a Process Agent**: File a Form BOC-3, designating a legal agent in each state where you plan to operate or haul freight, who can receive and forward legal documents.

Compliance and Safety

- 8. **Develop a Safety Management Plan**: This should include driver qualification files, drug and alcohol testing programs, and vehicle maintenance records.
- 9. **Enroll in a Drug and Alcohol Testing Program**: Enroll with a DOT-compliant drug and alcohol testing consortium.
- 10. **Obtain Insurance**: Obtain the required liability and cargo insurance. The minimum requirement is usually \$750,000, but it can vary depending on what you haul.
- 11. **File Proof of Insurance (Form BMC-91 or BMC-91X):** File it with the FMCSA to prove you have the required insurance coverage.

Post-Application Steps

- 12. **Unified Carrier Registration (UCR)**: Register with the UCR program, which is required for carriers operating across state lines.
- 13. **International Registration Plan (IRP) and International Fuel Tax Agreement (IFTA):** If you plan to operate in multiple states, you'll need to register for both IRP and IFTA for your vehicles.
- 14. **Comply with State Requirements**: Check for any additional permits or registrations required by the states in which you'll operate.
- 15. **FMCSA New Entrant Safety Assurance Program**: Complete the New Entrant Safety Assurance Program, which includes a safety audit within the first 12 months of operation.
- 16. **Maintain Records and Compliance**: Keep detailed records of your operations, including driver logs, vehicle maintenance, and insurance documentation, to ensure ongoing compliance with FMCSA regulations.
